### Director Appointment

David is currently an independent director of EROAD Limited and Westpac New Zealand Limited and Chair of BT Funds Management (NZ) Limited. David brings extensive governance and management experience in the banking and finance sector having previously worked for 14 years at ANZ Group including as Singapore CEO and Head of South East Asia, India & Middle East. David has also served as Chair of the Institute of Finance Professionals New Zealand, Director of ANZ Bank (Europe) Ltd and Executive Board Member of the New Zealand China Council.

It is anticipated that David will be appointed as Chair following a transition period. Current Chair, Director Tim Storey will remain for the transition period, and intends to stand down on or before the 2026 Annual Shareholder Meetings.

Chair Tim Storey commented "We are very pleased to announce the appointment of David Green to the Stride Boards. David has a strong understanding of capital markets and his background in governance, together with his extensive experience in the finance and funds management sectors will be very valuable for the ongoing oversight and leadership of Stride Property Group."

In accordance with the NZX Listing Rules, David will retire and stand for election at the next Annual Shareholder Meetings of SPL and SIML.
